LOCATION: Colonial Beach Town Hill (at the corner of Colonial and Washington Avenues)

EVENT DATES: Saturday, October 26, 2019

TIMES: 11:00am - 6:00pm (Sat.)

FEES: \$35 per 10' x 10' space

\$10 additional per space electric fee upon request for electricity (Limited availability)

Reserved vendor parking will be available in the Wilder Lot and will be subject to daily/hourly kiosk rates. If you do not reserve a space (see signature page), you will need to secure your own parking.

RULES:

1. **Contracts are due September 26, 2019 and must include the completed and signed contract, payment, and a copy of your business license and health department certificate.**
2. **All food vendors must obtain a Westmoreland County Health Department permit at least 30 days prior to the event date. Call (804) 493-1124 for more information. Health Department Certificate must be on display during the event.**
3. **Contracts received after September 26 will be charged an additional \$20 depending on availability.**
4. A \$30 fee will be charged for all returned checks.
5. One vendor per space. Vendor or proxy must host display.
6. Spaces must be set up by 10:45am. You may arrive as early as 9am on October 26.
7. No vehicles will be allowed on Town Hill except for loading and unloading.
8. Confirmation provided upon receipt of Contract/payment. **Please include a valid email address.**
9. The entry fee is non-refundable for cancellations made fewer than 30 days from the event date.
10. This event takes place Rain or Shine.
11. By signing the Contract to participate as a vendor in the 5th Annual Colonial Beach Fall Festival & Golf Cart Parade, all parties acknowledge and agree that the Town of Colonial Beach and/or the Colonial Beach Chamber of Commerce, or any persons affiliated with these entities, will not be held responsible for theft, loss and/or damage to any property, or liable for injury to any participant.
12. The Fall Festival Committee/Chamber of Commerce Staff reserve the right to dismiss vendors for inappropriate wares, behavior, or customer interactions.
13. Please understand, there will be no "off-sides" vending without prior permission.
14. Vendors **MUST** park away from Town hill after unloading your vehicle.
15. Please manage your booth's trash.
