LOCATION: Colonial Beach Town Hill (on the corner of Colonial and Washington Avenues)

EVENT DATE: Saturday and Sunday, August 7 & 8, 2021

TIME: 8:00am - 4:00pm (both days)

FEES: \$70 per each 10' x 10' space (covers both days)

10% Town Fee

(10% for one 10X10 space - \$7. For every additional 10X10 space, pay another \$7)

\$15 additional per space electric fee upon request for electricity (Limited availability)

**Parking will be subject to daily/hourly kiosk rates. You will need to secure your own parking.**

RULES:

1. **Contracts are due August 1, 2021 and must include the completed and signed contract, payment, and a copy of your business license.**
2. **Contracts received after August 1, 2021 will be charged an additional \$20 (depending on availability).**
3. A \$30 fee will be charged for all returned checks.
4. One vendor per space. Vendor or proxy must host display.
5. It is required that all vendors will stay for the entire festival.
6. Spaces must be set up by 7:45am. You may arrive as early as 7am on August 7th.
7. Confirmation provided upon receipt of contract/payment. **Please include a valid email address.**
8. The entry fee is non-refundable for cancellations made fewer than 30 days from the event date.
9. This event takes place Rain or Shine.
10. By signing the contract to participate as a vendor in the 41<sup>st</sup> Annual Rod Run to the Beach, all parties acknowledge and agree that the Town of Colonial Beach and/or the Colonial Beach Chamber of Commerce, or any persons affiliated with these entities, will not be held responsible for theft, loss and/or damage to any property, or liable for injury to any participant.
11. The 41<sup>st</sup> Annual Rod Run to the Beach Committee/Chamber of Commerce Staff reserve the right to dismiss vendors for inappropriate wares, behavior, or customer interactions.
