EVENT DATE: Saturday October 23, 2021

TIME: 11:00am - 5:00pm

FEES: \$40 per each 10' x 10' space

10% Town Fee

(10% for one 10X10 space - \$4. For every additional 10X10 space, pay another \$4)

\$15 additional per space electric fee upon request for electricity (Limited availability)

Parking will be available in the Wilder Lot and will be subject to daily/hourly kiosk rates. You will need to secure your own parking.

RULES:

1. **Contracts are due October 10, 2021 and must include the completed and signed contract and payment.**
2. **Contracts received after October 10th will be charged an additional \$20.**
3. A \$30 fee will be charged for all returned checks.
4. One vendor per space. Vendor or proxy must host display.
5. It is required that all vendors will stay for the entire festival.
6. Spaces must be set up by 10:30am. You may arrive as early as 9am on October 23rd.
7. No vehicles will be allowed on Town Hill except for loading and unloading.
8. Confirmation provided upon receipt of Contract/payment. **Please include a valid email address.**
9. The entry fee is non-refundable for cancellations made fewer than 30 days from the event date.
10. This event takes place Rain or Shine.
11. By signing the Contract to participate as a vendor in the 7<sup>th</sup> Annual Colonial Beach Fall Festival & Golf Cart Parade, all parties acknowledge and agree that the Town of Colonial Beach and/or the Colonial Beach Chamber of Commerce, or any persons affiliated with these entities, will not be held responsible for theft, loss and/or damage to any property, or liable for injury to any participant.
12. The Fall Festival Committee/Chamber of Commerce Staff reserve the right to dismiss vendors for inappropriate wares, behavior, or customer interactions.
13. Please understand, there will be no "off-sides" vending without prior permission.
14. Vendors **MUST** park away from Town hill after unloading your vehicle.
15. Vendors are responsible for their own trash removal.
